Optimism and Pessimism

Our spring meeting saw the birth of the new Committee on Neuroscience, hailed with much enthusiasm and the bracketing of the meeting with presentations on the relevance of neuroscience for clinicians by Bernard Beitman. The Neuroscience Committee has begun the task of recruiting members and welcomes suggestions for new members. We also had ten first time guests, and voted in ten second time guests as new members.



The past few months have been active for publications and two committees have contracts for books and another one for a screenplay. This is a departure from the time when committees wrote first and then looked for publishers afterwards. The steering committee considered using a standardized application form, but after discussion decided the current method of an abbreviated CV for the first visit followed by a short biographical sketch for the second visit should be continued. Review of our financial status showed that, owing to our members' paying the full (albeit discounted) rate for their hotel rooms, we are no longer losing money on our meetings and for the time being, are doing well. The Planning and Communications Committee continues to work on improving our website and our visibility to the outside world. They emphasize that our products are what make us known.

Nearly everyone in leadership positions in psychiatry today talks about the paradox that we are in the best of times and worst of times. The trouble with clichés like this is that they are true, which is why they are clichés. Who would have thought forty years ago that we would be able to diagnose psychiatric disorders in infants and young children? Or to chose from many effective, evidence-based treatments, not only for adults, but also for children and adolescents? Who would have believed it likely that GAP would be producing a curriculum on teaching about gay, lesbian and transsexual issues? But who also would have believed that our alleyways would be filled with homeless people with severe and persistent mental illness? Or that most children and adolescents with mental illness would never see a mental health professional? Or that our veterans in need of intensive outpatient treatment would be housed in rotting buildings?

These problems remain daunting. The pessimistic view is that they are insoluble. They certainly won't be solved without the will to solve them on the part of society, and they won't be solved if they are ignored or believed to be intractable. But our knowledge, based on solid research, tells us they are not. Our challenge, and the challenge to GAP, is to communicate effectively to the profession and the public that things can and must change. We do this primarily through our work products. These products reflect our faith in our ability to bring about change, while maintaining a realistic view of the many problems we see around us and the obstacles we face. They are the result of the work, energy, time and commitment of our membership. And it is our membership that is our real strength.

One of my committee's former fellows, when asked to share what working with

the committee during the fellowship had meant to her, unhesitatingly responded that the most important part of the experience for her was exposure to people who had maintained their idealism over a lifetime. I'd like to mention three of them whom I've had the pleasure to work with-- Knight Aldrich, Skip Onesti, and Justin McCarthy.

At our spring meeting, we celebrated Knight Aldrich's 94th birthday. Knight has been a continuously active member of GAP throughout his long career. In addition to his contributions to the Committee on Disasters and Terrorism, he has served on the Publications Board for many years. Anyone who has labored over and submitted a manuscript for review to the Publications Board has experienced his incisive (sometimes painful, but always on the mark) critiques. On my own committee, Adolescence, we have benefited from the wisdom of Skip Onesti, who initially attended the committee as a Ginsburg Fellow and often regales us with stories of the freewheeling early days of the committee. Skip often sits quietly listening to the rest of the committee agonize over a draft that doesn't seem quite finished, and then picks up his pen and quickly makes it lucid and succinct. And, since becoming president, I have had the pleasure of getting to know better Justin McCarthy, a non-physician member who is a retired pharmaceutical company executive. When Justin's dreams of attending medical school were dashed by the Depression, he turned to work in the pharmaceutical industry. His career at Wyeth gave him the opportunity to work on the development and distribution of the Salk vaccine, thus being instrumental in ensuring that polio would no longer be a scourge of childhood. He has shared his wisdom with the Committee on Planning and Communications for many years and plans to attend his 100th GAP meeting in 2009.

In mentioning each of these people, I am aware that there are so many others whose stories of faith and commitment to the profession of psychiatry are inspiring. GAP owes a great deal to members like this who, in addition to inspiring new generations of members, have contributed to the work of GAP in so many ways. GAP obviously means a lot to them as well -- and it is to our benefit that it does. On behalf of all of us, thank you for all you have done and all you will continue to do.

The Committee is working on two projects, a fast track article "Suboxone: A Practical Update for Clinicians" targeted at mental health providers to be submitted for publication in medical/psychiatric journals. An intermediate length manuscript "A Patient's Guide to Prescription Opiates for Pain Management" targeted at the general public to be submitted for publication in monograph form to the AACP. The manuscripts will be edited. With the Pilot Study, the Committee will be communicating with the GAP membership about voluntary participation in the study.

Manuscript #1:

The committee is working on a manuscript lead by Michael Myers on "Psychiatrist Burn-Out: Special factors affecting IMG Psychiatrists at risk for career burn-out". This manuscript is in first draft, anticipating completion by May 2009, targeted to psychiatrists to be submitted to Academic Psychiatry and Academic Medicine. Doctor Myers distributed his annotated literature review, which reflected considerable study of burn-out for physicians generally, but little about psychiatrists specifically, and almost nothing about IMG psychiatrists. He identified a validated tool the Maslach Burnout Inventory as a validated survey instrument he proposes to use a survey a defined cohort of IMG psychiatrists, combined with demographic data related to specific IMG stressors. Doctor Myers will complete the literature review and develop study design for the survey. The first draft of the literature review and study design will be finalized and implemented.

The Publications Board could help with the editorial review.

Manuscript #2:

The committee is working on a manuscript “Pre-Residency Externship-Observership Psychiatry Programs in the US: Survey and Review” lead by Diane Sacks. This manuscript is in first draft anticipated to be completed by May 2009, targeted to psychiatrists, psychiatry training directors, and psychiatry chairs. The manuscript will be submitted to Academic Psychiatry and Academic Medicine.

The Publications Board could help with editorial review.

Doctor Sacks distributed her draft survey instrument to Survey Monkey free format, which she proposes to administer to directors of Externships, Observerships, and Research Assistanceships which are offered at psychiatry departments through the US. The Committee discussed methods for identifying these programs and how best to maximize survey returns. Doctor Sacks will let me members know when the online version is ready for review. Members will visit the web version and email Doctor Sacks their feedback, especially feedback about streamlining the format to decrease subject resistance to completing and submitting the completed instrument. The committee will review the final survey instrument and further identify two geographic regions in which to pilot the instrument, with the help of members.

Manuscript #3:

The Committee is working on a manuscript “Culturally Competent Psychiatric Interviewing Revisited: Are There New Lessons from the IMG Experience?” The lead author is Jacob Sperber and the first draft is in preparation. The anticipated date is May 2009, targeted to psychiatrists and allied mental health practitioners to be submitted to Academic Psychiatry.

The Publications Board might be helpful in editorial help.

Doctor Sperber presented a draft on conceptual review of cultural competency, seeking to integrate a system of concepts of culture from a hierarchy of the social sciences, locating current psychiatric practice within this hierarchy. He has presented results of a pilot survey of the GAPIMG Committee’s Culturally Competent Psychiatric Interviewing Assessment Tool, in which 7 committee members applied to tool of videorecordings of three 30 minute interviews of vignette based psychiatric interviews of standardized patients (SPs) by IMG residents. (SP technology and actors provided by NYCOM ICC, Director Tony Errichetti, Ph.D., study collaborator.) A qualitative look at which tool items had good inter-rater reliability led to discussion of specific ways to improve the tool. The exercise provoked a lively debate about conflicting models of cultural psychiatry, and whether the educational needs of IMG’s as a group justify separate attention in the area of competent assessment interviewing.

Doctor Sperber will complete literature based conceptual section and review the tool based on the pilot qualitative trial results and the discussion which followed. Obtain IRB approval of qualitative study at two participating programs. Run the project again with residents from two programs, with culturally sharpened vignettes, using only senior residents, sampling IMG and AMG senior residents, asking each committee member to rate videorecorded interviews by two AMG senior residents and by two IMG senior residents. The plan is to compile results for presentation next meeting. The initial compilation of new data, discuss implications for inclusion in the next draft. The committee will locate AGM residents source in region of NYCOM ICC SP lab (Nassau County), conceptual input from interested mbmers.

INTERNATIONAL RELATIONS:

The Committee is working on an intermediate length report “Theoretical Models Used in International Relations.”

This project is in the beginning of development targeted to mental health providers and the general public. The Committee will be working to review models used in previous publications. For the next GAP Meeting, the Committee will discuss models used and what other models could be applied to International Relations.


